Proposal to Increase Local Sales and Use Tax Rate**

Shall the governing body of the incorporated municipality of the City of North Platte increase the local sales and use tax rate by an additional one-half of one percent (1/2%) from the current rate of one and one-half percent (1 1/2%) to a rate of two percent (2%) and impose a sales and use tax at the increased rate upon the same transactions within such municipality on which the State of Nebraska is authorized to impose a tax, with all revenues generated by the additional one-half of one percent (1/2%) to be used for public infrastructure projects within the City of North Platte or voter approved infrastructure related to an economic development program as defined by Neb. Rev. Stat §18-2705?
