Guards will contact 911 to notify Law Enforcement."

Review of Treasurer's Office security procedures. Booker will talk to Lorie regarding security and lockdown procedures in the relocated Treasurer's Office.

Committee received a letter from Clerk of the District Court's office regarding incidents that have taken place the last couple of months and complimenting guards' responses. Committee will invite Clerk of the District Court to the next meeting to review security in her office.
